COMPLAINT FOR LIBEL AND DEFAMATION, HARASSING COMMUNICATIONS, INTERLOCUTORY AND PERMANENT INJUNCTION, ATTORNEY'S FEES, PUNITIVE DAMAGES AND OTHER RELIEF

COMES NOW Plaintiff, MICHAEL S. MORRISON, and files this his Complaint for Libel and Defamation, Harassing Communications, Interlocutory and Permanent Injunction, Attorney's Fees, Punitive Damages and Other Relief against Defendant, ISAAC CADY, showing to the Court the following:

1.

Defendant, Isaac Cady, is an individual Defendant subject to the jurisdiction and venue of this Honorable Court. Defendant may be served at the following address, towit: 1445 Woodland Hills Drive, Atlanta, Georgia 30324.

Introduction and Background

2.

Plaintiff Michael S. Morrison (hereinafter "Morrison") and Defendant Isaac Cady (hereinafter "Cady") are neighbors. Mr. Morrison resides at 1449 Woodland Hills Drive,

Atlanta, Georgia 30324 and Mr. Cady resides at 1445 Woodland Hills Drive, Atlanta, Georgia 30324.

3.

During the spring/summer, 2023, Cady began stalking and harassing Morrison and his family.

4.

During the summer of 2023, Cady routinely and repeatedly spied and surveilled Morrison's property as well as Morrison, his family and invited guests. Specifically, Cady often appeared on his rooftop looking down at Morrison's pool at the back of his property. Defendant often videotapes, while masturbating, Morrison's fiancé sunbathing by his pool.

5.

On July 26, 2023, the Atlanta Police Department created an incident report regarding Cady's conduct. A true and correct copy of said Incident Report is attached hereto as Exhibit "A."

6.

Cady obtained Morrison's fiancé's phone number from the Police Report and began texting her. Morrison's fiancé demanded that he cease and desist from contacting her and reported his conduct to the Atlanta Police Department.

On November 22, 2023, Morrison approached Cady (speaking with him for the first time) requesting that he cease from removing the edging for a path that Morrison had constructed for Cady's mother. During the conversation, Cady picked up a hammer and threatened Morrison's person. Cady then contacted the police falsely claiming that Morrison threw water at him.

8.

Thereafter, Cady initiated at least two family violence stalking petitions against Morrison, seeking a temporary protective order and other relief. Both of Cady's stalking petitions were dismissed by this Court thereby denying Cady any relief against Morrison.

General Allegations

9.

Cady, frustrated by the dismissal of his legal actions against Morrison, posted on the parties' neighborhood "Next Door" website numerous false, misleading and defamatory statements concerning Morrison. A true and correct copy of the aforesaid posting is attached hereto as Exhibit "B."

10.

Cady's defamatory and false statements against Morrison include the following:

- (a) Cady accuses Morrison of being a "smut-peddler;"
- (b) Cady accuses Morrison of being a "general degenerate;"
- (c) Cady accuses Morrison of being a "blackmailer;"
- (d) Cady accuses Morrison of being a "trespasser;"

- (e) Cady accuses Morrison of being a "stalker;"
- (f) Cady accuses Morrison of being a "falsifier of evidence;"
- (g) Cady accuses Morrison of being a "falsifier of police reports" against Cady;
- (h) Cady accuses Morrison of being a narcissistic sociopath; and
- (i) Cady accuses Morrison of being a "pathological liar."

11.

In his published statements on the Next Door website, Cady further falsely published that Morrison is "currently under police investigation for battery against [Cady], stalking and trespassing on [Cady's] property." Such statements are false and defamatory as no law enforcement entity (federal, state, county or municipal) is currently investigating Morrison as set forth in Cady's published statements. Instead, it is Cady that is conducting a one-man "investigation/stalking and harassment" against Morrison.

12.

On February 23, 2024, counsel for Morrison wrote Cady a written demand concerning Cady's defamatory statement and a demand for a full retraction of the above-published statements by March 1, 2024. A true and correct copy of said demand is attached hereto as Exhibit "C."

13.

Cady failed and refused to publish any retraction whatsoever in response to Morrison's demand.

Count I <u>Libel and Defamation</u>

14.

Morrison incorporates by reference paragraphs 1 through 13 of his Complaint as if fully set forth herein.

15.

Cady's defamatory statements and conduct towards Morrison constitute a false and malicious defamation against Morrison which has injured his reputation and exposed him to public hatred, contempt or ridicule.

16.

Cady's actions towards Morrison constitutes libel and defamation in accordance with O.C.G.A. § 51-5-1 et seq.

17.

Cady's social posts to third parties making false allegations against Morrison demonstrates that Cady has published these statements to third parties within the meaning set forth in O.C.G.A. § 51-5-3.

18.

Cady's false and defamatory statements towards Morrison constitutes libel *per se* within the meaning of O.C.G.A. § 51-5-5.

19.

Morrison is entitled to judgment against Cady for the damages caused by his false statements in an amount to be determined at trial, in an amount of at least \$500,000.

Count II <u>Harassing Communications</u>

20.

Morrison incorporates by reference paragraphs 1 through 19 of his Complaint as if fully set forth herein.

21.

Cady has contacted third parties, via social media posts and other forms of electronic communications for the purpose of harassing, molesting, threatening or intimidating Morrison and/or his family members.

22.

Cady's communications with third parties regarding Morrison constitutes harassing communications within the meaning of O.C.G.A. § 16-11-39.1.

23.

Morrison is entitled to judgment against Cady for all damages caused by Cady's harassing communications in an amount to be determined at trial.

Count IV Interlocutory and Permanent Injunction

24.

Morrison incorporates by reference paragraphs 1 through 23 of his Complaint as if fully set forth herein.

Cady's actions are causing Morrison irreparable harm and substantial damages by materially harming his reputation, destroying his relationship with his friends and family and subjecting him to public ridicule.

26.

In accordance with O.C.G.A. §§ 9-5-1 et seq. and 9-11-65 et seq., Morrison seeks an interlocutory and permanent injunction restraining Cady from continuing to make his defamatory, false and harassing statements to his family, friends, associates, neighbors and third parties.

27.

Morrison shows that (1) there is a substantial threat that he will suffer irreparable injury if the relief set forth herein is not granted; (2) the injuries being caused Morrison outweigh the threat and harm that the injunction may do to the Cady; (3) there is substantial likelihood that Morrison will prevail on the merits of his claims at trial; and (4) granting interlocutory injunction will not disserve the public interest.

28.

Morrison will suffer irreparable injury if an injunction preventing the Cady's further defamation is not granted.

Count IV **Punitive Damages**

29.

Morrison incorporates by reference paragraphs 1 through 28 of his Complaint as if fully set forth herein.

30.

Cady's actions against Morrison show a willful misconduct, malice, fraud, wantonness, oppression and an entire want of care, which raises the presumption of Cady's conscious indifference to the consequences of his actions.

31.

Morrison is entitled to punitive damages in accordance with O.C.G.A. § 51-12-5.1

32.

Morrison prays for an award of punitive damages in an amount sufficient to penalize, punish or deter Cady from similar actions in the future, but no less than in an amount of \$250,000.

Count V Attorney's Fees

33.

Morrison incorporates by reference paragraphs 1 through 32 of his Complaint as if fully set forth herein.

34.

Cady has acted in bad faith, has been stubbornly litigious and has caused Morrison unnecessary trouble and expense.

As a result of the foregoing, Morrison is entitled to an award of his attorney's fees and expenses of litigation in accordance with O.C.G.A. § 13-6-11.

WHEREFORE, Plaintiff demands judgment in his favor and prays for the following relief:

- (a) Under Count I, that Plaintiff have judgment against Defendant for all damages caused by Defendant's libel and defamation of Plaintiff in an amount to be determined at trial, but not less than the sum of \$500,000;
- (b) Under Count II, that Plaintiff have judgment against Defendant for all damages caused by Defendant's harassing communications in an amount to be determined at trial;
- (c) Under Count III, that this Court enter an interlocutory and permanent injunction against Defendant restraining him from making any further, incorrect, defamatory, harmful or harassing statements against Plaintiff;
- (d) Under Count IV, that Plaintiff be awarded punitive damages in an amount sufficient to deter Defendant from such wrongful conduct in the future, but not less than the sum of \$250,000;
- (g) Under Count V, that Plaintiff be awarded his attorney's fees and expenses of litigation;
 - (h) For such other and further relief as the Court deems just and proper.

I advised him that he should stay away from the roof top when he notice that Ms. Lipton-Smith is out in the pool and I will advise her as well to avoid the pool when she noticed you are tat the roof top.

CEASE AND DESIST DEMAND DEMAND FOR FULL RETRACTION

Dear Mr. Cady:

As you are aware, I represent Michael Morrison. The purpose of this correspondence is to address recent postings you have made on the "Next Door" website concerning my client. Specifically, you have posted numerous false, misleading and defamatory statements concerning Mr. Morrison designed to intimidate, harass and cause harm to him and his family.

I am enclosing a screenshot of your recent publication. Among other things, you accuse my client of the following:

- > Of being a smut peddler;
- General degenerate;
- Blackmailer;
- > Trespasser;
- > Stalker:
- > Falsifier of evidence:
- > Falsifier of police reports against you;
- > Being a Narcissistic Sociopath; and
- > Pathological Liar.

You also falsely published that Mr. Morrison is "currently under police investigation for battery against [you], stalking and trespassing on [your] property." Such statement is false and defamatory as no law enforcement entity (federal, state, county, municipal) is currently investigating Mr. Morrison as you falsely allege. Instead, it is you

that is conducting a one-man "investigation/stalking" and harassment against him. In fact, you are fully aware that the Superior Court of DeKalb County has dismissed, on at least two occasions, your stalking petitions against Mr. Morrison.

Your above-described conduct constitutes electronic stalking within the meaning of O.C.G.A. § 16-11-39.1 and defamation in accordance with O.C.G.A. § 51-5-5 et seq. Your false and defamatory statements against Mr. Morrison are so egregious and so calculated to cause harm and infamy against him that it constitutes libel per se under O.C.G.A. § 51-5-5, meaning damages are inferred and need not be proven.

Based upon the above and foregoing, my client demands an immediate full written retraction of the above-described published statements on the Next Door website. Demand is hereby made that you publish a retraction by Friday March 1, 2024, and provide the undersigned counsel with a copy of the same. The retraction should advise the public that all of your previous statements and allegations against Mr. Morrison are FALSE and you retract all of said statements against him.

Demand is further made that you cease and desist from making any further false and defamatory statements against Mr. Morrison and cease and desist from any further electronic or personal stalking of him and his family.

Your failure to take the above-described actions shall result in Mr. Morrison initiating a defamation/stalking complaint against you in a court of competent jurisdiction where he will seek a full measure of damages against you, punitive damages and attorney's fees.

Govern yourself accordingly.
