THEREFORE, Petitioner requests:

- (a) That the Court set a hearing within thirty (30) days of the signing of the Order and to direct Respondent to appear before this Court and to show any reasons why the demands of the Petitioner should not be granted;
- (b) That the Respondent be served a copy of this Petition and Ex Parte Protective Order as required by law;
- (c) That this Court direct law enforcement to enforce this Order;
- (d) That this Court direct Respondent to stop abusing, harassing and intimidating Petitioner's child/ren;
- (e) That this Court restrain and enjoin Respondent from having any direct or indirect contact with the petitioner and/or Petitioner's child/ren;
- (f) That this Court order that Respondent be enjoined from approaching within \_\_\_ yards of Petitioner;
- (g) That this Court make findings of fact and conclusions of law concerning the issues in this case;
- (h) That Petitioner have such other and further relief as the Court may deem just and proper;
- (i) That this Court issue a Stalking Act Ex Parte and Twelve Month Protection Order; and
- (j) That this Court grant such other relief as it determines just and equitable.



**STATEMENT OF CLAIM**

COMES NOW Defendant, MICHAEL SCOTT MORRISON, and files this his Statement of Claim showing to the Court the following:

1.

Plaintiff is a resident of DeKalb County, Georgia, and is over the age of eighteen years.

2.

Defendant is a resident of DeKalb County, Georgia, and is subject to the jurisdiction and venue of this Honorable Court.

3.

Plaintiff resides at 1449 Woodlands Hills Drive, N.E., Atlanta, Georgia 30324. Defendant resides at the adjoining property.

4.

On November 22, 2023, Defendant approached Plaintiff requesting that he cease from removing the edging for a path that Plaintiff had constructed for Defendant's mother. During the conversation, Defendant picked up a hammer and threatened Plaintiff's person. Defendant then contacted the police falsely claiming that Plaintiff threw water at him.

During the summer of 2023, Defendant routinely and repeatedly spied and surveilled Plaintiff's property as well as Plaintiff, his family and invited guests. Specifically, Defendant often appeared on his roof top looking down at Plaintiff's pool at the back of his property. Defendant often videotapes, while masturbating, Plaintiff's fiancé sunbathing by his pool.

6.

On July 26, 2023, the Atlanta Police Department created an Incident Report regarding Defendant's conduct. A true and correct copy of said Incident Report is attached hereto as Exhibit "A."

7.

Defendant obtained Plaintiff's fiancé's phone number from the police report and began texting her. Plaintiff's fiancé demanded that he cease and desist from contacting her and reported his conduct to the Atlanta Police Department.

8.

The above-described actions and conduct of the Defendant constitutes stalking within the meaning of O.C.G.A. § 16-5-90. Defendant is engaging in harassing and intimidating conduct by willfully engaging in conduct which causes emotional distress by placing Plaintiff in reasonable fear for Plaintiff's safety and/or the safety of his family.

9.

Defendant's above-described acts have no legitimate purposes and are without the consent of Plaintiff, and placed Plaintiff in reasonable fear for his own safety and/or the safety of his immediate family.

10.

Defendant has, on at least two occasions, initiated stalking petitions against Plaintiff in this Court and both cases have been dismissed by this Court.

WHEREFORE, Plaintiff respectfully requests:

(a) That the Court set a hearing directing Defendant to appear before this Court and to show cause for any reasons why the demands of the Plaintiff should not be granted;

(b) That this Court direct Defendant to stop abusing, harassing and intimidating Plaintiff and his fiancé;

(c) That this Court restrain and enjoin Defendant from videotaping or recording Plaintiff's pool on his property;

(d) That this Court restrain and enjoin Defendant from having any direct or indirect contact with the Plaintiff and the Plaintiff's fiancé;

(e) That this Court order that Defendant be enjoined from approaching within twenty feet of the Plaintiff or Plaintiff's family;

(f) That this Court award Plaintiff his reasonable attorney's fees and costs in accordance with O.C.G.A. § 16-5-94(d)(3);

- (g) That this Court order Defendant to receive appropriate psychiatric or psychological services as a further measure to prevent the recurrence of stalking;
- (h) That this Court issue a Twelve Month Protection Order;
- (i) That Plaintiff have such other and further relief as the Court deems just and proper.

**NARRATIVE**

On the 25th July 2023, I Officer A. Akingbona was flagged down at 1739 Cheshire Bridge on information to public indecency.

Mr. Michael Morrison said, he had an issue with his neighbour that was masturbating when his girlfriend was in the pool located at the back of his house. He advised that this has been going on when ever his girlfriend go to the pool.

Mr. Morrison showed me some pictures showing his neighbour at the roof top looking down at the pool. The neighbour was later identified as Mr. Isaac Cady.

I spoke to Ms. Skyler Lipton-Smith, she advised on several occasion when she was at the pool, her neighbour (Mr. Isaac Cady) will come to his roof top window and started masturbating. She said, Mr. Cady will hold on to a phone and always keep his eyes on him with the other hand down.

I spoke to Mr. Cady and he said, he was out on the roof top to play (Banjo game). He said, he was not masturbating and he was not in good times with Mr. Morrison. He said, all is a lie, and he doesn't speak to him.

I advised him that he should stay away from the roof top when he notice that Ms. Lipton-Smith is out in the pool and I will advise her as well to avoid the pool when she noticed you are at the roof top.
